KNOW ALL MEN BY THESE PRESENTS, That in consideration of THREE HUNDRED SEVENTY- NINE THOUSAND FIVE HUNDRED DOLLARS AND NO/100's (\$37,9500.00) to the undersigned grantor, CORNERSTONE BUILDING COMPANY, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto BRADFORD KEVIN DOSS and CHRISTINE SHAW DOSS (herein referred to as GRANTEEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

And I/we do for myself/ourselves and for my/our heirs, executors, and administrators, covenant with said GRANTEEES their heirs and assigns, that I am/we are lawfully seized in fee simple of said premises, that they are free from all encumbrances, unless otherwise noted above, that I/we have a good right to sell and convey the same as aforesaid, and that I/we will and my/our heirs, executors, and administrators shall warrant and defend the same to the said GRANTEEES, their heirs executors and assigns forever, against the lawful claims of all persons.


