KNOW ALL MEN BY THESE PRESENTS:

That in consideration of ONE HUNDRED SIXTY THOUSAND AND NO/100 DOLLARS (\$160,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, E. D. Haney, a married man, Cris A. Nelson, a married woman, and Steven E. Haney, a married man, (hereinafter referred to as grantors), grant, bargain, sell and convey unto City of Helena, Alabama, a municipal corporation, (herein referred to as grantee), the following described real estate, situated in Shelby County, Alabama, to-wit:

The NW 1/4 of the NW 1/4, Section 15, Township 20 South, Range 3 West, Shelby County, Alabama.

There is reserved to grantors all minerals, including oil and gas; together with the right to produce and mine said minerals from the above described property by subterranean mining methods so long as such mining methods do not damage or disturb the surface of said property or any buildings or improvements thereon, and so long as such mining does not involve open-pit strip-mining or other surface-removal methods, and so long as such mining leaves adequate support for overlying strata, the surface of said land, any buildings, water courses, lakes or roads located thereon.

The above described property is no part of the homestead of any of the grantors herein.
