Commence at the Southeast corner of the NW 1/4 of SE 1/4 of Section 26, Township 20, Range 3 West; thence run along the South line of said 1/4 - 1/4 Section a distance of 580.41 feet to the point of beginning of the property herein conveyed; thence continue along last described course a distance of 110 feet to a point; thence turn right 93 deg. 10 min. 56 sec. and run North a distance of 452.14 feet to a point; thence turn right 86 deg. 48 min. 32 sec. and run East a distance of 140.92 feet to a point; thence turn right 97 deg. 04 min. 57 sec. and run South a distance of 454.93 feet to the point of beginning

together with all appurtenances thereto, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, and all the estate, right, title, interest, property, possession, claim and demand whatsoever, both in law and equity, which Kathleen Hill had in her lifetime and at the time of her death, and which Executor has, by virtue of the Will of Kathleen Hill, or otherwise, of, in, and to the above-granted premises, and every part and parcel thereof, with the appurtenances.
