

**ARTICLES OF ORGANIZATION
OF
ALABASTER FLORIST, LLC**

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be: Alabaster Florist, LLC.

**ARTICLE II
DURATION**

This Limited Liability Company ("LLC") shall exist for a period of fifty (50) years.

**ARTICLE III
PURPOSES**

This LLC is created for the purpose of operating a retail flower and gift shop and engaging in such other related businesses as may be agreed upon by the members from time to time.

**ARTICLE IV
REGISTERED AGENT/OFFICE**

ARTICLE VI
NEW MEMBERS

New members shall be admitted to the LLC upon the approval of all of the existing members, upon such terms and conditions as the members may from time to time establish.

ARTICLE VII
DISSOCIATION

The continued membership of a member shall be terminated upon the occurrence of any of the following events:

1. withdrawal, death, disability or retirement of the member; or
2. filing in bankruptcy, insolvency, or assignment for the benefit of creditors by the member, or filing of a voluntary or involuntary petition in bankruptcy.

Upon the occurrence of such an event, the LLC shall continue its business.


ARTICLE VIII
CAPITALIZATION


The initial amount of capital contributions (including cash and a description of the agreed value of property) is One Thousand Dollars (\$1,000), which shall be contributed by the members.

ARTICLE IX
MANAGEMENT

The LLC will be managed by its members whose names and addresses are set forth in Article V hereof.
