QUITCLAIM DEED

Deed made on the 21st day of September, 1995, by PHILLIP W. WHITE, Grantor, to POK C. WHITE, Grantee.

Grantor, in consideration of Ten Dollars (\$10.00) and other valuable consideration paid by Grantee, does hereby remise, release and forever quitclaim to Grantee, that real property located in the State of Alabama, more particularly described as follows:

As a point of reference begin at the intersection of the South boundary of the longview Road with the Easterly boundary of Alabama Highway 119; thence in a southerly direction along the easterly boundary of said Highway 2013 feet to a point; thence turn to the left and run Easterly parallel with the North boundary of said SW 1/4 of SE 1/4 a distance of 1230 feet more or less, to point which is on the Eastern boundary of said 1/4 1/4 section; thence turn 180 degrees and run back in the same direction following the last call a distance of 405 feet to the point of beginning; thence turn to the left and run southerly parallel with the eastern boundary of said 1/4 1/4 section a distance of 210 feet to a point; thence turn to the right and run westerly parallel with the northern boundary of said 1/4 1/4 section a distance of 210 feet to a point; thence turn to the right and run easterly parallel with the northern boundary of said 1/4 1/4 section a distance of 105 feet to the point of beginning.
