

**ARTICLES OF INCORPORATION****OF****J.R. HOLLON ADVISORY SERVICES, INC.**

The undersigned, acting as the incorporator of a corporation pursuant to the Code of Alabama, hereby adopt the following Articles of Incorporation for such corporation:

**ARTICLE I.        *NAME***

The name of the corporation is **J.R. HOLLON ADVISORY SERVICES, INC.** (hereinafter referred to as the "Corporation").

**ARTICLE II.        *DURATION***

The term of existence of the corporation is perpetual.

**ARTICLE III.        *PURPOSE***

The purpose for which the corporation is organized is to provide advisory services and for the transaction of any and all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act.

**ARTICLE IV.        *REGISTERED OFFICE AND REGISTERED AGENT***

**ARTICLE V.        *CAPITAL STOCK***


