CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

That in consideration of ONE HUNDRED TWENTY SEVEN THOUSAND TWO HUNDRED EIGHTY FIVE & NO/10---- (\$127,285.00) DOLLARS to the undersigned grantor, Carter Homes and Development, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Thomas H.
