**ARTICLES OF ORGANIZATION
OF
CAMBRIAN RIDGE, L.L.C.**

We, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is Cambrian Ridge, L.L.C.
2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby, Alabama, and shall continue until December 31, 2050, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. The purpose for which this Limited Liability Company is organized is to engage in the transaction of any lawful business permitted under the laws of the State of Alabama, including the purchase and development of real estate.
4. The location and mailing address of the initial registered office shall be 3170 Highway 31 South, Pelham, Alabama 35124, and the name of the initial registered agent at said address shall be Roy L. Martin.
5. The names and mailing addresses of the initial members in the Limited Liability Company are as follows:

6. The members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon the unanimous consent of all the members of the Limited Liability Company.

7. The members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which


