WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of FIVE HUNDRED DOLLARS AND 00 CENTS (US\$500.00) Dollars to the undersigned GRANTORS in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, Thomas M. Trussell, an unmarried man and Yvette L. Trussell, an unmarried woman, (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto Yvette L. Trussell, an unmarried woman, (hereinafter referred to as GRANTEE), the following described real estate situated in the County of Shelby and State of Alabama, to-wit:
