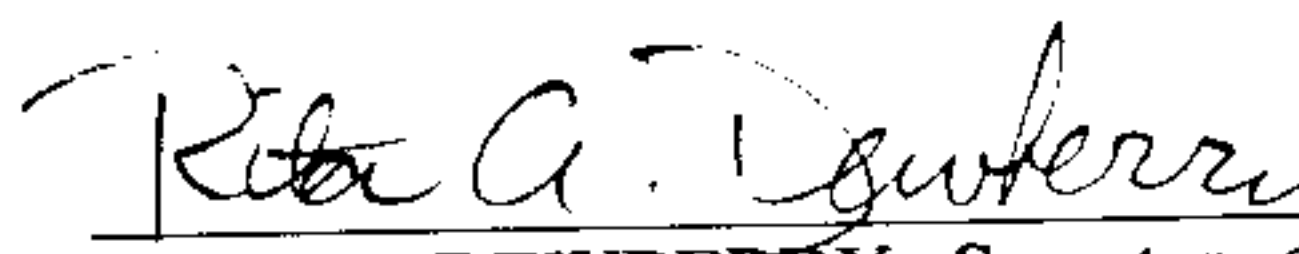
- I. The name of the corporation is Rita-Rich Investments, Inc.
