## SUBORDINATION AGREEMENT

THIS SUBORDINATION OF MORTGAGE executed this 22nd day of December, 1995, by National Bank of Commerce of Birmingham (hereinafter referred to as the "Mortgagee").

## WITNESSETH:

WHEREAS, Mortgagee is the owner and holder of that certain Real Estate Mortgage (with a current principal balance of 180,530.02) from L. J. Steeley, SR. and wife, Dean Steeley to Coats & Co., Inc., to refinance the original mortgage recorded in Instrument #1993-40317, in the Office of the Judge of Probate of Shelby County, Alabama, which encumbers the above described property; provided, however, that this subordination is limited to the amount of \$180,530.02.
