Code § 10-3A-140 (1975), a Statement of Intent to Dissolve the Corporation was duly filed in the Office of the Judge of Probate of Shelby County, Alabama, and in connection therewith we do make the following further statements:

- (a) The name of the Corporation is The J. A. Brown Foundation.
- (b) A Statement of Intent to Dissolve the Corporation was filed on the 29<sup>th</sup> day of December, 1995, in the Office of the Judge of Probate of Shelby County, Alabama.
- (c) That all known debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefor.
- (d) No Plan of Distribution was adopted by the Corporation.
- (e) That pursuant to Article IV of the Articles of Incorporation of the Corporation and in accordance with the provisions of Ala. Code § 10-3A-1, et al., all of the remaining property and assets of the Corporation have been distributed exclusively to charitable,


