If Mortgagors fail to keep said property insured as above specified, Mortgages may insure said property (but Mortgagee is not obligated to do so) for its insurable value against loss by fire, wind and other hazards for the benefit of Mortgagors and Mortgages or for the benefit of Mortgages alone, at Mortgages's election. The proceeds of such insurance shall be paid by the insurer to Mortgagee, which is hereby granted full power to settle and compromise claims under all policies, to endorse in the name of Mortgagors any check or draft representing the proceeds of any such insurance, and to demand, receive and give receipt for all sums becoming due thereunder. Upon failure of Mortgagers to reimburse Mortgages for all amounts so expended, at the election of Mortgages and with or without notice to any person, Mortgages may declare the entire indebtedness secured by this mortgage due and payable and may foreclose this mortgage as hereinalter provided or as provided by law.

- 9. That if default shall be made in the payment of any of the indebtedness hereby secured, or in the performance of any of the terms or conditions of this mortgage, Mortgages may proceed to collect the rent, income and profits from the mortgaged property, either with or without the appointment of a receiver (to which appointment Mortgagors hereby consent), and Mortgages may notify the lessess or other payors thereof to make payment directly to Mortgages.
