Commence at a #5 re-bar found in place marking the Southwest corner of the NW 1/4 of SW 1/4, Section 31, Township 20 South, Range 2 East; thence run Easterly along the South boundary line of said NW 1/4 of SW 1/4, a distance of 264.34 feet to a #5 re-bar found in place and the point of beginning; thence continue along the same line of direction a distance of 50.02 feet to a #5 re-bar set; thence turn an angle of 91 degrees 14 minutes 47 seconds to the left and run a distance of 225.52 feet to a #5 re-bar set; thence turn an angle of 38 degrees 00 minutes 47 seconds left and run a distance of 241.49 feet to a #6 re-bar found in place; thence turn an angle of 53 degrees 57 minutes 21 seconds to the left and run a distance of 178.58 feet to a #6 re-bar found in place; thence turn an angle of 90 degrees 13 minutes 10 seconds to the left and run a distance of 183.99 feet to a #8 re-bar found in place; thence turn an angle of 87 degrees 45 minutes 48 seconds to the left and run a distance of 270.17 feet to a 1 1/4 inch pipe found in place; thence turn an angle of 89 degrees 57 minutes 11 seconds to the right and run a distance of 224.47 feet to the point of beginning.
