SUBORDINATION OF NOTE AND MORTGAGE

THIS SUBORDINATION OF NOTE AND MORTGAGE is made as of the *11th* of January, 1996, by Walter J. O'Dazier and wife, Rachel M. O'Dazier.

WITNESSETH:

WHEREAS, on September 29, 1995, Michael L. Gunter Enterprises, Inc., an Alabama corporation, did execute a Note and Mortgage in favor of Acton Development Corporation ("Acton") in the amount of \$25,000.00, said Mortgage being recorded at Instrument No. 1995-18718, in the Probate Office of Shelby County, Alabama.

WHEREAS, on September 29, 1995, Acton assigned said Mortgage and Note to Walter J. O'Dazier and wife, Rachel M. O'Dazier, (the "O'Daziers") by Assignment of Mortgage which is filed for record at Instrument No. 1995-28719, in said Probate Office.

WHEREAS, First Alabama Bank is willing to make a new loan to Gunter Oil Company, Inc. (being one and the same as Michael L. NOW, THEREFORE, in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned does hereby covenant, consent and agree that the lien of the Note and Mortgage of the O'Daziers be, and the same hereby is, made subordinate, inferior and subject in every respect to all liens and mortgages of First Alabama Bank, and to all renewals, replacements, consolidations, modifications, assignments and extensions thereof including any extensions of credit intended to be secured thereby, such as, but not limited to, any future advances.
