Amendment to Adjustable-Rate Line of Credit Mortgage

This amendment (the "Amendment") is made and entered into on <u>December 05, 1995</u>, by and between <u>DAVID D, PATE AND WIFE GINA G.</u>

<u>PATE</u> (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, (hereinafter called the "Mortgagee").

- B. The Mortgagor has executed in favor of the Mortgagee an Adjustable-Rate Line of Credit Mortgage (the "Mortgage") recorded in 1995 at page 07270, in the Probate Office of Shelby, County, Alabama. Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
