WARRANTY DEED

THIS IS A WARRANTY DEED executed and delivered this 19th day of January, 1996, by **P & R Southland Properties, Inc.**, an Alabama corporation, (hereinafter referred to as the "Grantor") to **M. Byrom Corporation**, an Alabama corporation (hereinafter referred to as the "Grantee").

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of the sum of One Hundred Forty-Five Thousand Six Hundred Twelve Dollars and 16/100ths (\$145,612.16) and other valuable consideration in hand paid by the Grantee to Grantor, the receipt and sufficiency of which are hereby acknowledged, the Grantor does by these presents, grant, bargain, sell and convey unto the Grantee, the interest of Grantor in the real estate specifically described as follows and located in Shelby County, Alabama, to-wit:

Lots 3, 4, 5 and 6, according to the Survey of Riverchase Cove, as recorded in Map Book 20, Page 109 in the Probate Office of Shelby County, Alabama;

TOGETHER WITH all appurtenances thereto belonging or in anywise appertaining and all right, title and interest of Grantor in and to any and all roads, alleys and ways bounding said premises.

This conveyance is subject to the following:

1. Ad valorem taxes (as per separate agreement) and assessments for 1996;
2. Building setback line of 10 feet, public easements and restrictions, limitations and conditions as set out in the Survey of Riverchase Cove recorded in Map Book 20, page 109;

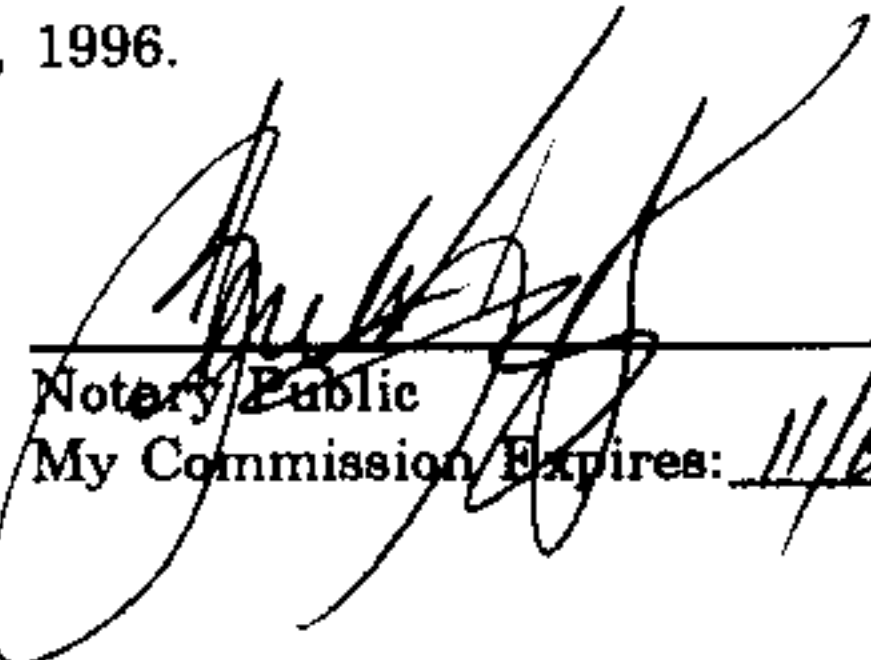
