I, Charles T. Anglin, the undersigned, a Free, White Citizen within the meaning of the Preamble to and the Constitution for the United States of America, of the People of the Sovereign Body Politic of the State of Alabama hereby affirm, declare and give notice that:

1. I, Charles T. Anglin, am of lawful age and competent, a Free, White Citizen of the People of the Sovereign Body Politic of the State of Alabama by natural birth and inheritance and thereby within the United States of America, protected by the Constitution for the United States of America and by the Constitutions of the several States, including...

STATEMENT OF ORIGINAL STATUS

2. I, Charles T. Anglin, a Free White Citizen, of the People of the Sovereign Body Politic of the State of Alabama, was born on or about May 31, 1951, in the county of Jefferson, in the State of Alabama, a State of the United States of America; and,

3. I, Charles T. Anglin, was sired by Charlie Thomas Anglin a Free, White Citizen, within the meaning of the Preamble to and the Constitution for the United States of America, and thereby of the People of the Sovereign Body Politic of the State of Georgia, born on or about October 26, 1922, in the county of Troup, in the state of Georgia, a State of the United States of America; and,

4. I, Charles T. Anglin, was given birth by Margaret G. Anglin, a Free, White Citizen of the State of Alabama, born on or about September 12, 1925 in the county of Sumter, in the State of Alabama, a State of the United States of America; and,

5. Charlie Thomas Anglin and Margaret G. Anglin were one, joined in the state of Holy Wedlock at the time Charles T. Anglin was natural born to them; and,

STATEMENT OF CAUSE

6. The Motor Vehicle Certificate of Title, License and Regi-

stration have lost their original espoused purpose to recover stolen property, they are now instruments of the state of Alabama used to transfer true Bills of Sale to a subdivision of the State of Alabama and are no longer within the common law jurisdiction pursuant to the original purpose of government to protect the Life, Liberty and Property of the Citizens; and,

7. The Motor Vehicle Certificate of Title, License and Registration are deployed through misrepresentation to impair, extort and divest me of my God-given Unalienable Rights, including, but not limited to, my Rights to Travel and Property through uninformed implied and/or other consent obtained from me without revealing to me the implications of such consent, now being a stealthy encroachment on my Rights as a Free Citizen to have the Rights of Possession and Ownership in my Property without which my status as a Citizen, as stated above, would be, and is, impaired and subjects me to the statutory jurisdictions of agencies, officers, employees, assigns and other affiliates that continually act in trespass of the limitations of the Constitution for the State of Alabama and the Constitution for the United States of America, in violation of Gods Law, imposing the evils denounced by the Declaration and Resolves of the First Continental Congress (1774) and the Declaration of Independance; and,

8. Only by my consent can the Government or its constituents exercise authority over my Rights including my Property Rights preserved by the Constitution for the state of Alabama or outside the Constitution for the United States of America; and,

9. All power lies within me to accept or deny control in areas which lie outside the Constitution for the United States of America and/or are protected by the Constitutions of the several States that could pertain or attempt to pertain to me as one of "The Posterity" of the Preamble to the Constitution for the United States of America; and,

10. The Application for and Motor Vehicle Certificate of Title, License and Registration do not contain any warning, whatsoever, that any Rights are being waived or that a privilege is being obtained instead of my vested Rights nor does said Application set forth or indicate where those conditions may be found; and,

11. I was deceived into believing that Application for and issue of a Vehicle License, Registration and Certificate of Title were a legitimate function of the government agency issuing same and that I was, or could be, required to execute same in order to exercise my Rights to have access and egress to public property in any lawful conveyance and to own, possess and freely use my private property in the form of a private automobile for the above said purpose; and,

RESCISSION FOR CAUSE

12. WHEREFORE, formal notice is hereby given that I, Charles T. Anglin, was in fact duped, deceived and misled into submission without my informed consent by the(se) device(s) and cloak(s) of the Government(s) of the United States and of the several States, do hereby RESCIND, CANCEL and REPUDIATE the Applications for Certificate of Title, License and Registration on Automobile #JM2UP213XKO703088; I will hereafter assume full responsibility for the said automobile identified above while exercising full Rights of Possession and Ownership as protected by law for the aforementioned cause and specifically deny any consent whatsoever for the past, this day and for all time; and,

13. WHEREFORE, formal notice is also given that I, Charles T. Anglin, hereby repudiate all statutory benefits and obligations of the aforesaid Applications for and Certificate of Title, License and Registration; that I absolutely will not use accounts established thereunder, identifying numbers or other identifiers which represent said account, except to repudiate same and that I will not apply for, receive, collect or attempt to apply for, receive or collect, any privilege or benefit established thereunder and that said Applications for Certificate of Title, License and Registration will be treated as though they never had been established as fully and completely as if same had never been applied for or assigned; and

INTENT

14. My intent is to be a Free, White, Citizen of the People of the Sovereign Body Politic, as above said, in the State of Alabama, by virtue of birth and inheritance, and thereby, a Citizen within the United States of America and Co-Heir to the Organic Law as stated in The Declaration of Independance and as restated in the Preamble to the Constitution for the United States of America, which I am in fact by said Organic Law; to claim my God-given Rights declared by the Statute of 1776, and the limitations on government set out in the Constitution for the United States of America; and to re-establish myself as a Citizen (de jure) pursuant to my Rights as Co-Heir to the Statute of 1776 and the Organic Law, to the end of preserving the Christian Republics of the United States of America as formed, and limited, by the Constitution for the United States of America and further limited by the Bill of Rights and the Constitutions of the several States; and,

NOTICE TO TRESPASSERS

15. This is notice to all who would subject me to a deprivation of my Rights and corresponding responsibility as a Citizen pursuant to the Declaration of Independance. All claimants have thirty (30) days from the date of this "Notice by Affidavit" to make any claims such claimants may wish to assert in a Court of Law; failure to do so is an admission of estoppel and laches upon

all comers. Any further deprivation of my vested Rights by any governmental agent(s) or agency(ies) will be, by its taking place a declaration of Mixed War between codified statutory law and common law waged against me by whatever person or entity who might commit such trespass and will be remedied by whatever action is necessary and lawful, taking into account the moral gravity of the deprivations in the particular instance; and,

16. The statements and information contained herein are true and correct to the best of my knowledge, are set forth for cause, superseding any previous denials of aforementioned I may have made to date, and my Signature and Seal hereafter are the voluntary act of my own hand; and,

FURTHER AFFIANT SAITH NOT.

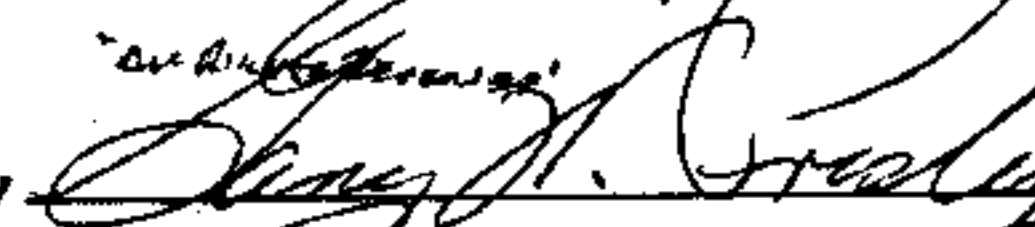
