That in consideration of ONE HUNDRED THIRTY FOUR THOUSAND SIX HUNDRED TWENTY FIVE & NO/100---- (\$134,625.00) DOLLARS to the undersigned grantor, Carter Homes and Development, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto John Johnson and wife, Kirsten M.
