That in consideration of ONE HUNDRED FIFTY TWO THOUSAND FIVE HUNDRED TEN & NO/100---- (\$152,510.00) DOLLARS to the undersigned grantor, Jackie Williams Co., Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Gayle S.
