ORDER

This cause came on to be heard for trial on November 20, 1995. The plaintiff appeared with its counsel, James F. Burford, III. Defendant, Randall W. Cash, did not appear, however, his counsel, Bryce Scott Davis, was present. Neither the Defendants, Floyd Berman and Elaine Axel, as Trustees under the Will of Vellye E. Berman, or their counsel appeared. The Intervenor-Plaintiff, Dixie Acoustical Contractors, Inc., had previously filed a motion for summary judgment.

The court had been earlier informed that the Defendant, Randall W. Cash, would be seeking the protection of the Bankruptcy Court. However, no filed Bankruptcy Petition was presented and further, the U.S. Bankruptcy Court in Birmingham, Alabama had not received any petition on behalf of Randall W. Cash under Chapters 7, 11 or 13. The court has been informed that Europa Corporation has filed a Chapter 11 Bankruptcy Petition on 11/20/95.

Based upon the pleadings and arguments of counsel, it is ORDERED, ADJUDGED and DECREED by the court as follows:

1. Plaintiff Awad Construction Co., Inc. shall have and recover from the Defendant Randall W. Cash the following:

The sum of \$62,795..42 principal plus interest on \$77,795.42 from February 19, 1995 to May 30, 1995; in the amount of \$1,278.83. Interest on \$72,795.42 from May 30, 1995 to June 30, 1995 in the amount of \$358.99; and interest on \$62,795.42 from June 30, 1995 to November 20, 1995 in the amount of \$1,546.64 for a total of \$65,979.88.

- 2. Intervenor-Plaintiff, Dixie Acoustical Contractors, Inc. shall have and recover from the plaintiff, Awad Construction Co.. Inc. the sum of \$13,820.00 principal plus \$631.06 interest, for a total of \$14,541.06.
 - 3. A lien is hereby imposed upon any lease between the Defendant, Randall W. Cash and the Defendants, Floyd Berman and Elaine Axel, as Trustees under the Will of Vellye E. Berman, and further, such lien shall extend to the improvements placed on the property which is the subject of said lease, more specifically described as:

Lot 18, and the West 50 feet of Lot 20, in Block 102, according to the plan of the City of Birmingham, as laid off by the Elyton Land Company, situated in the City of Birmingham, Jefferson County, Alabama,

said improvements having been installed and placed upon such real property by the plaintiff Awad Construction Co., Inc. and the Intervenor-Plaintiff Dixie Acoustical Contractors, Inc. and further, said real estate is condemned for the satisfaction of the indebtedness evidenced by this judgment pursuant to Code of Alabama (1975) Section 35-11-212; and further, such lien is superior to any interest or title of the Defendant, Randall W. Cash.

4. The costs of court accrued herein are taxed to Defendant, Randall W. Cash.
