That in consideration of ONE HUNDRED FORTY SIX THOUSAND & NO/100---- (\$146,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEEES herein, the receipt whereof is acknowledged, we, Rodney E. May and wife, Gail T. May (herein referred to as grantors), do grant, bargain, sell and convey unto Hugh Douglas Cockrell and wife, Sandra L. Cockrell (herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:

Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.


\$116,800.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
