A parcel of land situated in the NW 1/4 of the NW 1/4 of Section 28, Township 19 south, Range 2 west, Shelby County, Alabama, more particularly described as follows: Begin at the Northwest corner of said section and run in an Easterly direction along the north line of said section a distance of 640.21 feet to a point; Thence turn an interior angle of 92 15' 40" and run to the right and in a Southerly direction a distance of 663.85 feet to a point; Thence turn an interior angle of 87 44' 20" and run to the right and in a Westerly direction a distance of 832.55 feet to a point; Thence turn an interior angle of 92 55' 10" and run to the right and in a Northerly direction a distance of 666.20 feet to the point of beginning of herein described parcel, containing 12.77 acres more or less.
