CONTRACT, RELEASE AND AGREEMENT

WITNESS this agreement entered into this 25th day of November, 1995 by and between Chelsea Properties, Inc., an Alabama corporation, formerly known as Cloud & Estes, Inc. (hereinafter referred to as the "Developer"), and the individuals who have joined in the execution hereof and who are the owners of lots in the within described First Sector and Sector B of High Chaparral (hereinafter referred to as the "Signatory Lot Owners"):

WHEREAS, Developer acquired a tract of approximately 445 acres in Shelby County, Alabama, which is located in the Southeast Quarter and the Southeastern Quarter of the Southwestern Quarter of Section 7 and the Northwest Quarter of Section 18, Township 20 South, Range 1 West, and in the Eastern Half of the Northeastern Quarter, the Northern Half of the Southeastern Quarter, the Northeastern Quarter of the Southwestern Quarter of Section 13, Township 20 South, Range 2 West (hereinafter referred to sometimes as "Developer Property"), and

WHEREAS, Developer has subdivided portions of the Developer Property into single family lots in a subdivision that is commonly known as High Chaparral and which is more particularly described in the Plat of High Chaparral, First Sector (the "First Sector") as recorded in Map Book 12, Page 57A and B, in the Probate Office of Shelby County, Alabama, and the plat of High Chaparral, Sector B ("Sector B"), as recorded in Map Book 16, Page 69, as amended by the Resubdivision of Lots 48 through 57 of High Chaparral, Sector B and Acreage, as recorded in Map Book 16, Page 116, in said office, and

WHEREAS, the First Sector is subject to the Restrictions for High Chaparral, First Sector, which are reflected in the instruments recorded in Book 196 at Page 237, Book 237 at Page 729 and Book 273 at Page 75 in the Probate Office of Shelby County, Alabama, and those certain Restrictions for High Chaparral, First Sector Lake Use recorded in said Probate Office in Book 197, Page 240, as amended and modified by Amendment to Restrictions for High Chaparral, First Sector recorded as Instrument #1992-25021 and a Declaration of Easement and Restrictive Covenants recorded as Instrument #1992-23020, all recorded in the Probate Office of Shelby County, Alabama, and

WHEREAS, Sector B is restricted to certain covenants and restrictions pursuant to Declaration of Protective Covenants for High Chaparral, Sector B, as recorded in the Shelby County, Alabama Probate Office as Instrument #1992-25023, and that Declaration of Easements and Restrictive Covenants for Lake Use for

High Chaparral, Sector B recorded in said Probate Office, as Instrument #1992-25024, and

WHEREAS, Developer did execute a Declaration of Easement And Restrictive Covenants on or about October 20, 1992, recorded as Instrument #1992-25020 in the Probate Records of Shelby County, Alabama, and

WHEREAS, all easements, restrictions, plats, covenants and other documents above or hereinafter referred to at any place herein will sometimes hereinafter be referred to as (the "Prior Documents"), and

WHEREAS, the Prior Documents provide for the reservation of certain portions of High Chaparral as a "Common Area or Reserve for Equestrian Purposes" ("Equestrian Site") and "Common Area or Reserve for Swim and Tennis Facilities" ("Swim and Tennis Site"), and

WHEREAS, the Signatory Lot Owners are the owners of all lots previously sold in any and all Sectors of High Chaparral and, together with the Developer, are the owners of all property contained in both the developed and undeveloped portions of High Chaparral, and

WHEREAS, the Developer and the Signatory Lot Owners wish to execute this document which, among other things, removes fully and completely any obligation of Developer to construct the Equestrian Site and the Swim and Tennis Site, and further removes, releases and nullifies all easements created therefor and any and all obligation of Developer to design, construct, operate and/or maintain the same:

NOW, THEREFORE, in consideration of the above premises and in consideration of the mutual covenants and agreements contained herein, the parties hereto do hereby agree, covenant and contract as follows:

1. That the undersigned Signatory Lot Owners, separately and severally, warrant that they are the lawful owners of the lot, lots or parcels of land indicated herein in connection with their names, and that they each have the lawful right, power and authority to execute this document as the owner/owners thereof. The undersigned Signatory Lot Owners do further, separately and severally, warrant that if there is any mortgage or other lien or encumbrance against their lot, lots or parcels of land indicated herein, the name and identity of the holder of such mortgage, lien or encumbrance is shown attached hereto and that this document has been approved and executed by any and all holders of any mortgage, lien or encumbrance thereon.

2. The Developer warrants that it is the owner of all properties remaining in the Developer Property, with the

exception of those parcels heretofore sold to the Signatory Lot Owners, or their predecessors in title and Developer further warrants that it has the lawful right, power and authority to execute this document.

3. The previously pending application before the Shelby County Planning Commission for the Third Sector, High Chaparral, will be revised and refiled by Developer. The revision will provide for an alternate access to High Chaparral which will be made by connecting the Third Sector to Shelby County Highway Number 39 with a paved road along the right-of-way purchased for that purpose by the Developer. (This alternate access is shown on the Master Plan filed with the Shelby County Planning Commission in 1988.) This road will be completed by Developer and the shoulders of the road will be sowed by Developer with grass requiring low maintenance. The cul-de-sac presently proposed at the northern end of the Third Sector will be moved by the Developer to suit the reconfiguration of lots resulting from construction of the access road. The number of lots proposed by the Developer for the Third Sector will not be changed, however, and shall consist of thirty-three (33) lots. The Signatory Lot Owners will support and speak in support of the Developer's application before the Shelby County Planning Commission.

4. The land presently reserved for the proposed Equestrian Site and for the proposed Swim and Tennis Site, together with all easements and property related thereto, are hereby relinquished and released by the Signature Property Owners to the Developer for appropriate marketing as herein provided. All covenants, restrictions and easements created by the Prior Documents, or otherwise created pertaining to the development of the Equestrian Site and/or the Swim and Tennis Site and all rights, licenses, privileges and benefits and the use and enjoyment thereof, are hereby cancelled and made null and void. Developer is further relieved, separately and severally, from any and all duty and obligation, of any and all kind or character, to design, create, construct, operate or maintain said Equestrian Site and the Swim and Tennis Site. Developer shall further have and is hereby given the right, power and authority to execute any and all documents or amendments to the Prior Documents as are deemed desirable by Developer in its sole discretion in order to give effect to the provisions and terms hereof, including, but not limited to, the power to amend and/or vacate any and all plats, covenants and restrictions pertaining to either the Equestrian Site or the Swim and Tennis Site.

5. The above Signatory Lot Owners, separately and severally, do hereby, for themselves, their heirs, successors and assigns, release and forever discharge Developer from any and all duty or obligation to design, construct, operate and/or maintain the proposed Equestrian Site or the proposed Swim and Tennis Site and do specifically further release and convey to Developer, its

successors and assigns, any and all properties reserved or to which were to be reserved for such purposes.

6. The presently unplatted land of High Chaparral shall be incorporated into a revised Master Plan to be presented to the Shelby County Planning Commission no later than November 20, 1995. This revised plan will reflect the following:

Proposed Third Sector	33 lots
Former Equestrian Site and Lot 38	4 lots
Former Swim and Tennis Site and remaining 30 acres, more or less	<u>8 lots</u>
Total new lots from existing property	45 lots

The Developer may divide these proposed lots into any number of marketable sectors for approval by the Shelby County Planning Commission, provided no change in lot size or overall layout is made without concurrence of the Signatory Lot Owners. Developer shall have the right to make changes to accommodate drainage structure, terrain limitations and other technical concerns. Deed covenants for the above lots will be no less restrictive than those for Sector B of High Chaparral.

7. In consideration of the concessions herein made by the Signatory Lot Owners, the Developer agrees to reimburse the Signatory Lot Owners in the amount of Two Hundred Twelve Thousand Five Hundred and no/100 Dollars (\$212,500.00). This sum shall be divided and distributed equally among the property owners of record on a per lot basis, as such property owners of record exist on the date of the signing of this agreement by the Developer and the First Signatory Lot Owner. The Developer shall not be obligated to pay such sum until all of the following conditions have been met:

(a) The revised Master Plan above referred to shall receive approval by the Shelby County Planning Commission.

(b) All Signatory Lot Owners and any person, firm or corporation holding any mortgage, lien or encumbrance against any of the subject lots have signed this agreement and appropriate releases as are required to remove any and all obligations of Developer pertaining to the Equestrian Site and the Swim and Tennis Site.

(c) The Developer has sold forty-two (42) lots in the currently-platted sectors of High Chaparral.

The Developer will not request any continuances of action by the Shelby County Planning Commission after the revised Master Plan has been submitted.

The undersigned mortgagees or other entities holding any lien or encumbrance on any of the lots or parcels of land involved herewith do hereby waive payment to them of any money or funds provided in this agreement and stipulate that the same may be paid directly to the Signatory Lot Owners.

8. The Signatory Lot Owners will assume maintenance responsibility for the landscaping at the current entrance to High Chaparral when all parties have signed this agreement and will, thereafter, maintain the same in a neat and attractive condition. The Signatory Lot Owners and the future purchasers of lots will assume maintenance responsibility for the entry-way to be constructed as a part of the Third Sector at such time as sixty percent (60%) of the lots in the Third Sector have been sold. Said entry-way to be maintained thereafter in a neat and attractive condition. Property owners also agree to maintain their lot(s), including equestrian trails and rights-of-way, in a neat and attractive condition.

9. When construction of improvements has commenced in the Third Sector and any other future sectors of High Chaparral not presently of record, the Developer will erect a sign at the current entrance directing all construction vehicles accessing building sites in the Third Sector and any other unplatted areas of High Chaparral, to use the new entrance into the Third Sector. Such signs shall be maintained by Developer until all lots in the presently unplatted areas have been sold and the Developer will make every reasonable effort to assure compliance with this directive. The Architectural Review Committee will instruct the builders on approval of construction plans as to the appropriate entrance to be used for deliveries.

10. The Signatory Lot Owners and the Developer shall have the right to enforce the covenants and conditions set forth in this CONTRACT, RELEASE AND AGREEMENT and may proceed at law or in equity to compel compliance with the terms hereof or to recover any monetary damages, if any, due to a breach thereof, after having given written notice of such breach, and such breach continuing for more than thirty days thereafter; but no breach or violation of such covenants as contained herein shall invalidate or void the release of the covenants and conditions relating to the Equestrian Site or the Swim and Tennis Site, or invalidate or void any other provision or part hereof.
