Commence at the Southeast corner of said Lot 6, also being the Southwest corner of Lot 21, The Highlands - Sector 1 as recorded in Map Book 17, Page 100, along the North right of way of Highlands Drive, also being the point of beginning; thence run Southwesterly along said right-of-way a distance of fifteen feet; thence right 90 degrees 00 minutes, 10 feet Northwesterly; thence right 90 degrees 00 minutes, 15 feet Northeasterly to the Easterly property line of said Lot 6; thence right 90 degrees 00 minutes, 10 feet to the point of beginning.
