agether with all awards received through eminent domain, and payments upon any insurance policies covering the real estate, and all rights, privileges, mements, and appurtenances thereunto belonging or in anywise appertaining to said real estate including easements and rights-of-way appurtenant pereto and all gas, steam, electric and other heating, cooling and lighting apparatus, elevators, iceboxes, plumbing, stoves, doors and other fixtures opertaining to the real estate and improvements located thereon, all of which shall be deemed realty and conveyed by this mortgage.

TO HAVE AND TO HOLD the real estate, and every part thereof, unto Mortgagee, its successors and assigns forever. And Mortgagor covenants rith Mortgagee that it is lawfully seized of the real estate in fee simple and has a good right to sell and convey the same as aforesaid: that the real state is free of all encumbrances except as herein set out, and Mortgagor will warrant and forever defend the title to the real estate unto Mortgagee. s successors and assigns, against the lawful claims of all persons whomsoever.

THIS MORTGAGE IS MADE, however, subject to the following covenants, conditions, agreements, and provisions:

- 1. That Mortgagor shall pay the said indebtedness(es) secured hereby and interest thereon when and as it (they) shall become due, whether in ourse or under any condition, covenant or agreement herein contained, together with any other indebtedness(es) which Mortgagor may owe to fortgages, it being further agreed that any statement, any note or obligation that is secured by this mortgage shall be conclusive evidence of such fact.
- 2. (a) That Mortgagor shall provide, maintain and deliver to Mortgagee policies of fire insurance (with extended coverage), and such other insurance s Mortgages may from time to time require in companies, form, types, and amounts, and shall assign, with endorsements satisfactory to Mortgages, nd deliver to Mortgages with mortgages clauses satisfactory to Mortgages all insurance policies of any kind or in any amount now or hereafter issued rith respect to the real estate. Not later than the first day following the expiration date of any and all such insurance policies and at any time upon equest of Mortgages. Mortgagor shall furnish Mortgages certificates of insurance issued by insurance companies satisfactory to Mortgages showing hat the amount and type of insurance required by Mortgagee hereunder is in effect. All renewal policies, with premiums paid, shall be delivered to fortgages at least thirty (30) days before the expiration of the old policies. If any insurance, or any part thereof, shall expire,

repairment of the capital of any company by which the insurance may then be carried, or if for any reason whatever the insurance shall be insuffactory to Mortgagee, Mortgager shall procure and deliver to Mortgagee new insurance on the premises, satisfactory to Mortgagee. If Mortgager alists to procure and deliver such new insurance, Mortgagee may, but shall not be obligated to, procure same, and upon demand, Mortgager shall give simburse Mortgagee all such costs expended with interest on such advance at the rate set forth in the note secured hereby. Mortgager shall give mediate notice in writing to Mortgagee of any loss, injury or damage affecting the mortgaged real estate caused by any casualty or occurrence. Full ower is hereby conferred on Mortgagee to settle and compromise claims under all policies and to demand, receive, and receipt for all monies becoming ayable thereunder and to assign absolutely all policies to any holder of the note or to the grantee of the real estate in the event of the foreclosure of his mortgagee and security agreement or other transfer of title to the real estate in extinguishment of the indebtedness(es) secured hereby. In the event f loss covered by any of the policies of insurance herein referred to, each individual insurance company concerned is hereby authorized and directed to take payment for such loss directly to the Mortgagee instead of to the Mortgager and the Mortgagee jointly, and the insurance proceeds, after educting all costs of collection, including reasonable attorneys' fees, may be applied by the Mortgagee at its option, either as a payment on account of he indebtedness(es), secured hereby, whether or not then due or payable, or toward the restoration, reconstruction, repair, or alteration of the real state, either to the portion thereof by which said loss was sustained or any other portion thereof.

- (b) That together with and in addition to the monthly payment of principal and interest, and on the same date on which the principal and interest are ayable under the terms of the note secured hereby, Mortgagor, if required by Mortgagoe, shall deposit with the Mortgagoe, in a non-interest bearing count, a sum equal to one-twelfth (1/12) of the yearly taxes and assessments which may be levied against the real estate and which may attain riority over this mortgage, and ground rents, if any, plus one-twelfth (1/12) of the yearly premiums for insurance that will become due and payable to snew the insurance on the real estate for coverage against loss by fire or such other hazard as may reasonably be required by the Mortgagoe. The mount of such taxes, assessments, ground rents, and premiums when unknown, shall be estimated by the Mortgagoe. If the amount of funds held hall exceed at any time the amount deemed necessary by the Mortgagoe to provide for the payment of taxes, assessments, ground rents and surance premiums as they fall due, such excess shall be repaid to Mortgagor or credited to Mortgagor as Mortgagoe may determine. If the amount of he funds held shall not be sufficient at any time to pay taxes, assessments, ground rents, and insurance premiums as they fall due, Mortgagor shall ay to Mortgagoe any amount necessary to make up the deficiency upon notice from Mortgagoe to Mortgagor requesting payment thereof. Upon ayment in full of all sums secured by this mortgage, Mortgagoe shall promptly refund to Mortgagor any funds held.
- (c) That Mortgagor shall pay and discharge as the same become due all taxes and assessments that may accrue, be levied, or assessed upon the sal estate or any part thereof, which may be or become a lien prior to this mortgage or have priority in payment to the indebtedness(es) secured ereby, or upon Mortgagee's interest therein or upon this mortgage or the indebtedness(es) or evidence of indebtedness(es) secured hereby, without agard to any law heretofore or hereafter enacted imposing payment of the whole or any part thereof upon Mortgagee or upon the rendering by an appellate court of competent jurisdiction that the indebtedness(es) secured hereby without deduction shall, at the option of lortgagee, become immediately due and payable, notwithstanding anything contained in this mortgage or any law heretofore enacted; and Mortgagor hall not suffer or permit any such taxes on the said real estate to become or remain delinquent or permit any part thereof or any interest therein to be old for any taxes or assessments; and further shall furnish annually to Mortgagee, prior to the date when they become delinquent certificates or accipts of the proper offices showing full payment of all such taxes and assessments.
 - 3. That the real estate and the improvements thereon shall be kept in good condition and no waste committed or permitted thereon.
- 4. That no building or other improvement on the real estate shall be structurally altered, removed or demolished, without the Mortgagee's prior ritten consent, nor shall any fixture or chattel covered by this mortgage and adapted to the proper use and enjoyment of the real estate be removed at ny time without like consent unless actually replaced by an article of equal suitability owned by Mortgagor, In the event of any breach of this covenant se Mortgagee may, in addition to any other rights or remedies, at any time thereafter, declare the whole of the indebtedness(es) secured hereby ninediately due and payable.
- 5. That Mortgagor agrees that the indebtedness(es) hereby secured shalf at once become due and payable and this mortgage subject to foreclosure s provided for herein, at the eption of holder hereof, when and if any statement of lien is filed under the statutes of Alabama relating to the liens of sechanics and materialmen, without regard to form and contents of such statement, and without regard to the existence or nonexistence of the debt, r any part thereof, or of the lien, on which such statement is based.
- 6. That Mortgagor shall comply with all statutes, ordinances, regulations and laws promulgated by any governmental entity asserting jurisdiction ver the real estate and any and all legal requirements shall be fully complied with by Mortgagor.
- 7. That if Mortgagor fails to insure the real estate as hereinabove provided, or to pay all or any part of the taxes or assessments levied, accrued or seessed upon or against the real estate or the indebtedness(es) secured hereby, or any interest of Mortgagee in either, or fails to pay immediately and scharge any and all liens, debts, and/or charges which might become liens superior to the lien of this mortgage, Mortgagee may, at its option, insure neal estate and/or pay said taxes, assessments, debts, liens and/or charges and any money which Mortgagee shall have so paid shall constitute a ebt to Mortgagee additional to the indebtedness(es) secured hereby; shall be secured by this mortgage; shall bear the in-terest set out in the note ereinabove referred to from date paid or incurred; and, at the option of Mortgagee, shall be immediately due and payable.
- 8. That Mortgagor agrees that no delay or failure of Mortgagee to exercise any option to declare the maturity of any indebtedness(es) secured by his mortgage, shall be taken or deemed as a walver of its right to exercise such option, or to declare such forfeiture, either as to any past or present efault, and it is further agreed that no terms or conditions contained in this mortgage can be waived, altered or changed except as evidenced in writing, signed by the Mortgagor and by the holder hereof; and the procurement of insurance or the payment of taxes or other liens, debts or charges y Mortgagee shall not be taken or construed as a waiver of its right to declare the maturity of the indebtedness(es) hereby secured by reason of the niture of Mortgagor to procure such insurance or to pay such taxes, debts, liens or charges.
- 9. That if Mortgagee shall be made a party to any suit involving the title to the real estate and employs an attorney to represent it therein, or if fortgagee employs an attorney to assist in settling or removing any cloud on the title to the real estate hereby conveyed that purports to be superior to lie lien of this mortgage in any respect, Mortgagor will pay to Mortgagee, when the same becomes due, such attorney's fee as may be permitted by with any be reasonable for such services, and if such fee is paid or incurred by Mortgagee the same shall be secured by the lien of this mortgage addition to the indebtedness(es) secured hereby, and shall bear interest from the date it is paid or incurred at the rate set out in the note hereinabove ferred to and shall be at once due and payable.
- 10. That all expenses incurred by Mortgagee, including attorney's fee, in compromising, adjusting or defending against lien claims or encumbrances bught to be fixed upon the real estate hereby conveyed, whether such claims or encumbrances be valid or not, shall become a part of the debtedness(es) hereby secured.
- 11. That Mortgagor agrees to pay a reasonable attorney's fee as may be permitted by law to Mortgagee should the Mortgagee employ an attorney collect any indebtedness(es) secured by this mortgage.
- 12. That notwithstanding that the assignment of awards hereinabove referred to shall be deemed to be self executing. Mortgager, after the flowance of a condemnation claim or award, and the ascertainment of the amount due thereon, and the issuing of a warrant by the condemnor for the ayment thereof, shall execute, at Mortgagee's request, and forthwith deliver to Mortgagee, a valid assignment in recordable form, assigning all of such ondemnation claims, awards or damages to Mortgagee, but not in excess of an amount sufficient to pay, satisfy and discharge the principal sum of his mortgage and any advances made by Mortgagee as herein provided then remaining unpaid, with interest thereon at the rate specified herein, or in a note which this mortgage secures, to the date of payment, whether such remaining principal sum is then due or not by the terms of said note or of its mortgage.
- 13. That if Mortgagor shall make default in the payment of any of the indebtedness(es) hereby secured, or in the performance of any of the terms or onditions hereof. Mortgagee may proceed to collect the rent, income and profits from the real estate, either with or without the appointment of a sceiver; any rents, income and profits collected by Mortgagee prior to foreclosure of this mortgage, less the cost of collecting the same, including any sale estate commission or attorney's fee incurred, shall be credited first to advances with interest thereon, then to interest due on the principal idebtedness, and the remainder, if any, to the principal debt(s) hereby secured.

Mortgagor shall pay any such obligation imposed on Mortgagee thereby, and in the event Mortgagor fails to pay the obligation or is prohibited by law from making such payment, the whole of the principal sum secured by this mortgage, together with the interest e thereon shall, at the option of Mortgagee, without notice to any party, become immediately due and payable.

That should Mortgagor become insolvent or bankrupt; or should a receiver of Mortgagor's property be appointed; or should Mortgagor entionally damage or attempt to remove any improvements upon said mortgaged real estate; or should it be discovered after the execution and livery of this instrument that there is a defect in the title to or a lien or encumbrance of any nature on the real estate prior to the lien hereof; or in se of an error or defect in the above described note or this instrument or in the execution or the acknowledgment thereof; or if a homestead claim be true to the real estate or any part thereof adverse to this mortgage and if the said Mortgagor shall fail for thirty (30) days after demand by the ortgages, or other holder or holders of said indebtedness(es), to correct such defects in the title or to remove any such lien or encumbrance or

That it is the intent of the Mortgagor and Mortgagee to secure any and all indebtedness(es) of said Mortgagor to Mortgagee, now existing or reafter arising, due or to become due, absolute or contingent, liquidated or unliquidated, direct or indirect, and this mortgage is intended and does cure, not only the indebtedness hereinabove specifically referred to, but also any and all other debts, obligations and liabilities of said Mortgagor to id Mortgagee, whether now existing or hereafter arising, and any and all extensions or renewals of same, or any part thereof, at any time before tuel satisfaction and cancellation of this mortgage in the Probate Office where recorded, and whether the same be evidenced by promissory note, ien account, endorsement, guaranty agreement, pledge agreement, or otherwise; that it is expressly agreed that any indebtedness at any time cured hereby may be extended, rearranged or renewed and that any part of the security herein described may be waived or released without in liquidate waying or diminishing the force, effect or lien of this mortgage; and this mortgage shell continue as a first lien on all of the real estate id other property and rights covered hereby and not expressly released until all sums with interest and charges hereby secured are fully paid, and no her security now existing or hereafter taken to secure the payment of said indebtedness(es) or any part thereof shall in any manner be impaired or fected by the execution of this mortgage; and no security subsequently taken by Mortgagee or other holder or holders of said indebtedness(es) shall in manner impair or affect the security given by this mortgage; and all security for the payment of said indebtedness(es) or any part thereof shall be ken, considered and held as cumulative.

That Mortgagor shall furnish to Mortgagee within Thirty I 30 I days after the close of each fill Mortgagor, such financial records as the holder of this mortgage may require including, but not limited to, an annual statement of the operation of the all estate which shall include annual statements itemizing the income and expenses, an itemized rent roll, together with a complete financial statement. Mortgagor's assets and liabilities and its profit and loss statement. Such statement shall be prepared by certified public accountant acceptable to ortgagee or at Mortgagee's discretion be supported by the affidavit of Mortgagor. Said information shall be given to Mortgagee at no expense to ortgagee.
- 22. That if the indebtedness evidenced by the note specifically referred to hereinabove is being advanced by Mortgagee to Mortgagor under the rms and provisions and in accordance with a loan agreement or construction loan agreement ("agreement"), the terms and provisions of said preement are hereby incorporated by reference as part of this mortgage as if fully set out herein, and any default in the performance of the provisions ereof, or any contract or agreement between Mortgagor and Mortgagee, shall constitute a default hereunder entitling Mortgagee to exercise the medies provided herein, including the right to foreclose this mortgage in accordance with the terms hereof; that each FUTURE ADVANCE advanced by ortgagee to Mortgagor is being advanced in accordance with an agreement dated. Mar. 28, 1996 and is secured by this mortgage.
- 23. That in the event this mortgage is second and subordinate to any prior mortgage(s) and in the event the Mortgagor should fail to make any syments which become due on said prior mortgage(s), or should default in any of the other terms, provisions and conditions of said prior mortgage(s) cour, then such default under the prior mortgage(s) shall constitute an event of default under the terms and provisions of this mortgage, and the lortgagee herein may, at its option, declare the entire indebtedness(as) secured by this mortgage immediately due and payable and if payment is not comptly made, then declare this mortgage in default and subject to foreclosure, provided that the Mortgagee herein may, at its option, make, on behalf if Mortgagor, any such payments which become due on said prior mortgage(s), or incur any such expense or obligations on behalf of Mortgagor, in princetion with the said prior mortgage(s), in order to prevent the foreclosure of said prior mortgage(s), and all such amounts so expended by the ithin Mortgagee on behalf of said Mortgagor shall become a debt to the Mortgagee and shall be secured by this mortgage and shall bear interest from led date of payment at the maximum legal rate of interest from time to time permitted by the laws of the State of Alabama, and shall be at once due and payable, entitling the Mortgagee to all of the rights and remedies provided herein, including, at Mortgagee's option, the right to foreclose this ortgage.

That any promise made by Mortgagor herein to pay money may be enforced by a suit at law, and the security of this mortgage shall not be raived thereby, and as to such debts the Mortgagor waives all rights of exemption under the laws and Constitution of the State of Alabama and agrees pay as permitted by law a reasonable attorney's fee for the collection thereof.
- 26. That no delay or failure of Mortgages to exercise any option herein given or reserved shall constitute a waiver of such option or estop lortgages from afterwards exercising same or any other option at any time, and the payment, or contracting to pay, by Mortgages of anything lortgager has herein agreed to pay shall not constitute a waiver of default of Mortgagor in failing to make said payments and shall not estop lortgages from foreclosing this mortgage on account of such failure of Mortgagor.
