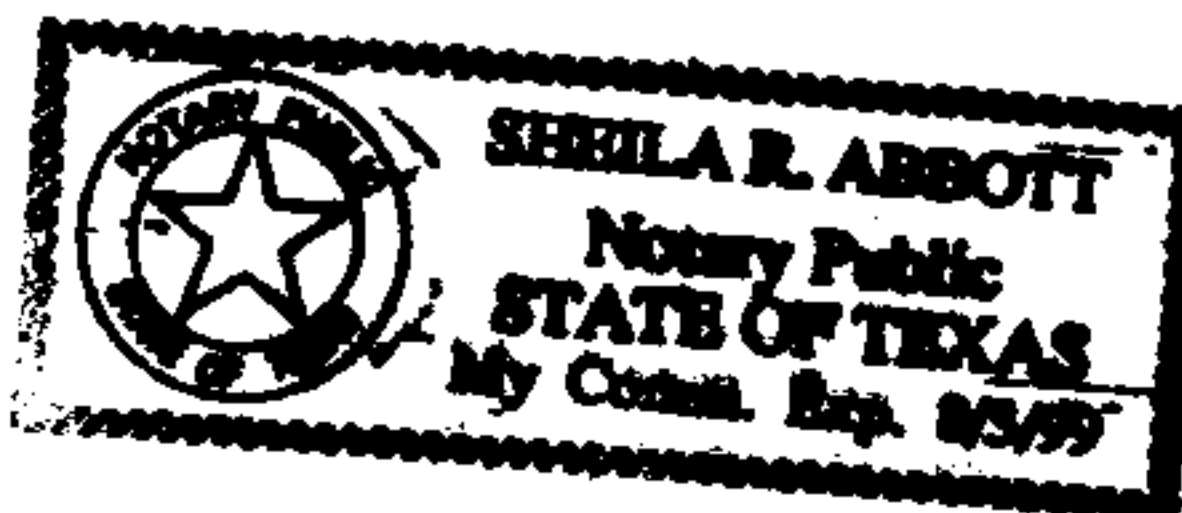

LEGAL DESCRIPTION

A parcel of land situated in the NW 1/4 of Section 23, Township 18 South, Range 2 East, Shelby County, Alabama, subject parcel being in all four 1/4 1/4 's of said NW 1/4 and described as follows:

Commence at the SW corner of the NE 1/4 of the NW 1/4 of Section 23, Township 18 South, Range 2 East, Shelby County, Alabama and run thence Easterly along South line of said 1/4 1/4 Section a distance of 246.60 feet to the point of beginning of the property being described; thence turn 117 deg. 30 min. 00 sec. left and run Northwesterly 469.00 feet to a point; thence turn 67 deg. 01 min. 57 sec. left and run Westerly 179.32 feet to a point on the Easterly margin of Shelby County Highway No. 57 in a curve to the left having a central angle of 83 deg. 21 min. 30 sec. and a radius of 333.59 feet; thence turn 93 deg. 18 min. 37 sec. left to chord and run Southerly along the chord of said curve a chord distance of 443.65 feet to the P. I. of said curve; thence turn 35 deg. 08 min. 46 sec. left from chord and run Southeasterly along said East margin of said highway 57 a tangent distance of 400.46 feet to the P. C. of a curve to the right; thence turn 3 deg. 32 min. 16 sec. right to chord and continue Southeasterly along chord of said curve a distance of 114.21 feet to a point; thence turn 85 deg. 03 min. 15 sec. left from chord and run Easterly 36.49 feet to a point; thence turn 20 deg. 28 min. 16 sec. right and run East-Southeasterly 118.17 feet to a point; thence turn 101 deg. 27 min. 56 sec. left and run Northwesterly 394.38 feet to the point of beginning; being situated in Shelby County, Alabama.
