Assignor does hereby WARRANT the unpaid balance on said Promissory Note to be not less than \$ \$168,000

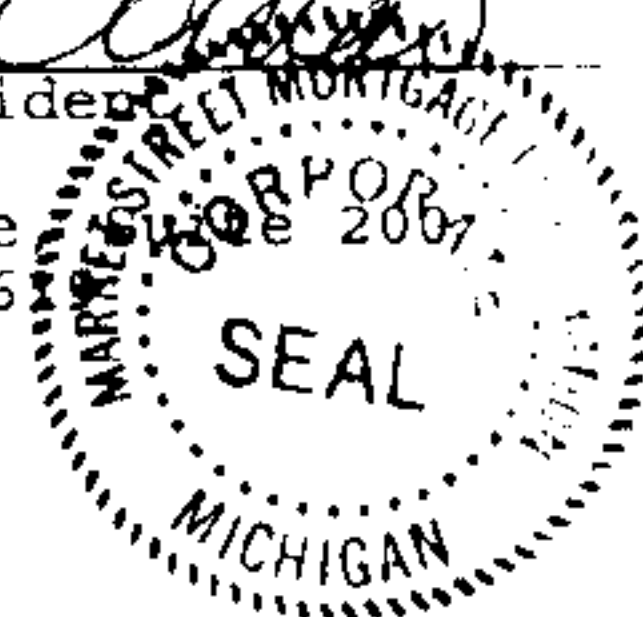

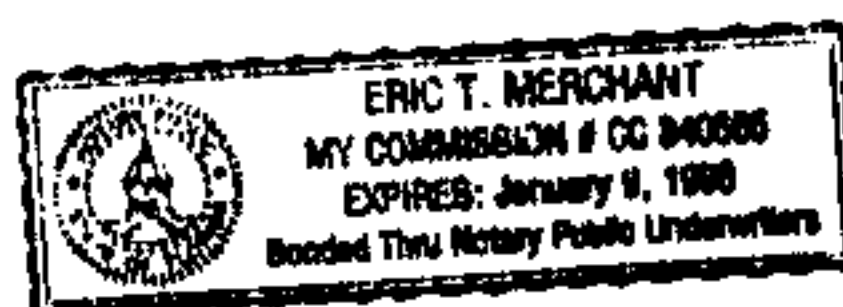
