Amendment to Adjustable-Rate Line of Credit Mortgage

This amendment (the "Amendment") is made and entered into on March 22, 1996, by and between LAURA L. TAYLOR, UNMARRIED (hereinafter called the "Mortgagor," whether one or more) and AmSouth Bank of Alabama, (hereinafter called the "Mortgagee").

- B. The Mortgagor has executed in favor of the Mortgagee an Adjustable-Rate Line of Credit Mortgage (the "Mortgage") recorded in 1996** at page 03417*, in the Probate Office of SHELBY, County, Alabama. Except as specifically amended hereby, the Mortgage shall remain in full force and effect in accordance with its terms.
