The NW 1/4 of the SE 1/4 of Section 12, Township 19 South, Range 1 East, Shelby County, Alabama. ALSO, the SE 1/4 of the NE 1/4 of Section 12, Township 19 South, Range 1 East, Shelby County, Alabama.
