 - 3. That the real estate and the improvements thereon shall be kept in good condition and no waste committed or permitted thereon.

That no building or other improvement on the real estate shall be structurally altered, removed or demolished, without the Mortgagea's prior ritten consent, nor shall any fixture or chattel covered by this mortgage and adapted to the proper use and enjoyment of the real estate be removed at ny time without like consent unless actually replaced by an article of equal suitability owned by Mortgagor. In the event of any breach of this covenant ne Mortgagee may, in addition to any other rights or remedies, at any time thereafter, declare the whole of the indebtedness(es) secured hereby nmediately due and payable.
- 5. That Mortgagor agrees that the indebtedness(es) hereby secured shall at once become due and payable and this mortgage subject to foreclosure s provided for herein, at the option of holder hereof, when and if any statement of lien is filed under the statutes of Alabama relating to the liens of sechanics and materialmen, without regard to form and contents of such statement, and without regard to the existence or nonexistence of the debt, r any part thereof, or of the lien, on which such statement is based.
- 6. That Mortgagor shall comply with all statutes, ordinances, regulations and laws promulgated by any governmental entity asserting jurisdiction ver the real cetate and any and all legal requirements shall be fully complied with by Mortgagor.
- 7. That if Mortgagor fails to insure the real estate as hereinabove provided, or to pay all or any part of the taxes or assessments levied, accrued or seessed upon or against the real estate or the indebtedness(as) secured hereby, or any interest of Mortgages in either, or fails to pay immediately and ischarge any and all liens, debts, and/or charges which might become liens superior to the lien of this mortgage, Mortgages may, at its option, insure real estate and/or pay said taxes, assessments, debts, liens and/or charges and any money which Mortgages shall have so paid shall constitute a ebt to Mortgages additional to the indebtedness(as) secured hereby; shall be secured by this mortgage; shall bear the in- terest set out in the note ereinabove referred to from date paid or incurred; and, at the option of Mortgages, shall be immediately due and payable.
- 8. That Mortgagor agrees that no delay or failure of Mortgages to exercise any option to declare the maturity of any indebtedness(es) secured by his mortgage, shall be taken or deemed as a waiver of its right to exercise such option, or to declare such forfeiture, either as to any past or present efault, and it is further agreed that no terms or conditions contained in this mortgage can be waived, altered or changed except as evidenced in vriting, signed by the Mortgagor and by the holder hereof; and the procurement of insurance or the payment of taxes or other liens, debts or charges in Mortgages shall not be taken or construed as a waiver of its right to declare the maturity of the indebtedness(es) hereby secured by reason of the silure of Mortgagor to procure such insurance or to pay such taxes, debts, liens or charges.
- 9. That if Mortgages shall be made a party to any suit involving the title to the real estate and employs an attorney to represent it therein, or if fortgages employs an attorney to assist in settling or removing any cloud on the title to the real estate hereby conveyed that purports to be superior to be lien of this mortgage in any respect, Mortgagor will pay to Mortgages, when the same becomes due, such attorney's fee as may be permitted by it and as may be reasonable for such services, and if such fee is paid or incurred by Mortgages the same shall be secured by the lien of this mortgage addition to the indebtedness(es) secured hereby, and shall bear interest from the date it is paid or incurred at the rate set out in the note hereinabove aferred to and shall be at once due and payable.

- 21. That Mortgagor shall furnish to Mortgages within Thirty (30) days after the close of each fill Mortgagor, such financial records as the holder of this mortgage may require including, but not limited to, an annual statement of the operation of the isi estate which shall include annual statements itemizing the income and expenses, an itemized rent roll, together with a complete financial statement. Mortgagor's assets and liabilities and its profit and loss statement. Such statement shall be prepared by certified public accountant acceptable to lortgages or at Mortgages's discretion be supported by the affidavit of Mortgagor. Said information shall be given to Mortgages at no expense to lortgages.
- 22. That if the indebtedness evidenced by the note specifically referred to hereinabove is being advanced by Mortgages to Mortgagor under the irms and provisions and in accordance with a loan agreement or construction loan agreement ("agreement"), the terms and provisions of said present are hereby incorporated by reference as part of this mortgage as if fully set out herein, and any default in the performance of the provisions is set of any contract or agreement between Mortgagor and Mortgages, shall constitute a default hereunder entitling Mortgages to exercise the imadies provided herein, including the right to foreclose this mortgage in accordance with the terms hereof; that each FUTURE ADVANCE advanced by iortgages to Mortgagor is being advanced in accordance with an agreement dated. Apr. 10, 1996 and is accurately this mortgage.
- 23. That any promise made by Mortgagor herein to pay money may be enforced by a suit at law, and the security of this mortgage shall not be raived thereby, and as to such debts the Mortgagor waives all rights of exemption under the laws and Constitution of the State of Alabama and agrees pay as permitted by law a reasonable attorney's fee for the collection thereof.
- 26.
