Upon failure of Mortgagers to reimburse Mortgages for all amounts so expended, at the election of Mortgages and with or without notice to any person. Mortgages may declare the entire indebtedness secured by this mortgage due and payable and may foreclose this mortgage as hereinster provided or as provided by law.
- 7. That no delay or fallure of Mortgages to exercise any option to declare the maturity of any debt secured by this mortgage shall be taken or deemed as a waiver of the right to exercise such option or to declare such forfeiture either as to past or present default on the part of Mortgagora, and that the procurement of insurance or payment of taxes or other liens or assessments or obligations by Mortgages shall not be taken or deemed as a waiver of the right to accelerate the maturity of the indebtedness hereby secured by reason of the failure of Mortgagors to procure such insurance or to pay such taxes, liens, assessments or obligations, it being agreed by Mortgagors that no terms or conditions contained in this mortgage can be waived, altered or changed except by a writing signed by Mortgagos.

- 9. That if default shall be made in the payment of any of the indebtedness hereby secured, or in the performance of any of the terms or conditions of this mortgage, Mortgages may proceed to collect the rent, income and profits from the mortgaged property, either with or without the appointment of a reselver (to which appointment Mortgagers hereby consent), and Mortgages may notify the lessess or other payors thereof to make payment directly to Mortgages.
