AFFIDAVIT AS TO HEIRSHIP

Personally appeared before me, the undersigned Notary Public in and for County, Mississippi, Rubin Triplett, who being duly sworn on oath, deposes and states as follows:

1. My name is Rubin Triplett, and I reside in Brooksville, Mississippi, and I make the statements in this affidavit to the best of my information, knowledge and belief.
2. I have been acquainted with the family of Maurice Jones-Williams <sup>for 25 years</sup> ~~for most of my life~~. I lived next door to the family for approximately <sup>25 years</sup> ~~25 years~~ prior to his death in 1945. <sup>12 (1971 - 1989)</sup>
3. Maurice Jones-Williams was married to Annie Irvine Jones-Williams who passed away in 1921. Maurice Jones-Williams and Annie Irvine Jones-Williams had five children namely:
  - a.) Maurice Jones-Williams, Jr., - who died as a teenager (at the age of 12 or 14). Maurice Jr. never married and had no children.
  - b.) Irvine Kinkaid Jones-Williams - who died in 1944 as the victim of a hit and run accident. Irvine had never married and had no children.
  - c.) Gladys Jones-Williams Rouderbush - who died in 1979. Gladys was married to Ralph Rouderbush, who died in 1952. They had no children.
  - d.) Annie Mary Jones-Williams - who was born in 1900 and died in 1993. Annie Mary never married and had no children. Her estate is currently being probated in Shelby County, Alabama, as Probate Case Number 32-183.
  - e.) Marion Cecilia Jones-Williams - who was born in 1907 and died in 1994. Marion Cecilia never married and had no children. Her estate is currently being probated in Shelby County, Alabama, as Probate Case Number 32-325.
4. Maurice Jones-Williams and Annie Irvine Jones-Williams did not have any other children, either born to them, or adopted by them, during their marriage.
5. Annie Irvine Jones-Williams died in 1921 and was survived by Maurice Jones-Williams.
6. After the death of his wife, Annie Irvine Jones-Williams in 1921, Maurice Jones-Williams never remarried.
