FINAL JUDGMENT AGAINST DEFENDANT DERRELL CHAMBLEE

Pursuant to the mandate of the United States Court of Appeals for the Eleventh Circuit, final judgment is hereby ENTERED in favor of plaintiff Jim Walter Resources, Inc. ("JWR") and against defendant Derrell Chamblee ("Chamblee") in the amount of \$669,601.79 on JWR's claim against Chamblee under the Alabama Fraudulent Transfer Act, Ala. Code § 8-9A-1 et. seq.. This represents the \$520,946.29 of transfers from W.C. Management, Inc. ("WCM") to Chamblee that JWR has documented and identified to the Court plus interest at the statutory rate of 6% from July 4, 1991.

On June 29, 1994 this Court entered judgment in favor of JWR and against WCM in the amount of \$1,074,714.23, which judgment was affirmed by the Eleventh Circuit. On or about May 2, 1995 JWR served a writ of garnishment on Chamblee with respect to the judgment against WCM, and Chamblee answered said garnishment on June 9, 1995 admitting that he was indebted to WCM in the amount of \$21,380.63. Thus, final

judgment is also ENTERED in favor of JWR and against Chamblee in the amount of \$21,380.63 on JWR's writ of garnishment.

The total judgment in favor of JWR and against Chamblee is \$690,982.42, and final judgment is hereby ENTERED in that amount. The costs of this action are taxed against Chamblee.
