KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED THIRTY-NINE THOUSAND DOLLARS AND NO/100's (\$339,000.00)** to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, I/we **KEN H. UNDERWOOD** and wife, **ELIZABETH LEA UNDERWOOD**, (herein referred to as grantors, whether one or more) do grant, bargain, sell, and convey unto **WALTER E. YARBROUGH and PINNIE H. YARBROUGH** (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 17, according to the Survey of Weatherly Subdivision, as recorded in Map Book 13, Page 1 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:


