That in consideration of TWO HUNDRED TWENTY FOUR THOUSAND SEVEN HUNDRED FIFTY & NO/100---- (\$224,750.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, William J. Christenberry and wife, Kimberly R. Christenberry (herein referred to as grantors), do grant, bargain, sell and convey unto Mark E.
