KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED NINETY THOUSAND FOUR HUNDRED DOLLARS AND NO/100's DOLLARS (\$290,400.00) to the undersigned grantor, VISTA HOMES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto GARI L. ESTILL and BARBARA L. ESTILL (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 744, according to the Map of Highland Lakes, 7th Sector, an Eddleman Community, as recorded in Map Book 20, Page 58 A, B & C, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
