This matter comes before the Court pursuant to the joint motion for entry of consent judgment by all the parties:

Upon consideration of the joint motion and other pleadings in this matter, this Court hereby FINDS, ORDERS, ADJUDGES, and DECREES that:

1. Judgment is hereby rendered in favor of the plaintiffs Thomas C. Gailey, Laurel A. Gailey, Wendall Patrick Cowart and Maureen Murphry Cowart and against defendants H. Evans Whaley and Whaley & Grimes, P.C. in the amount of Fifteen Thousand Dollars (\$15,000.00).

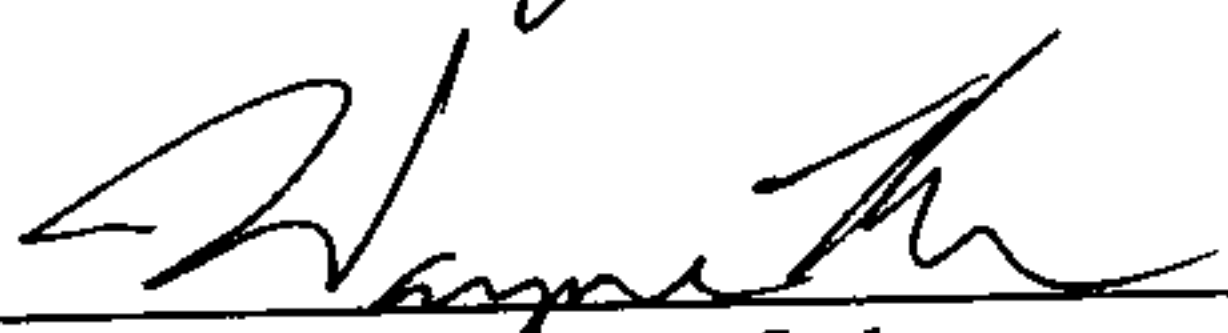
2. The parties have agreed that the judgment rendered by this Court shall be satisfied according to the specific payment schedule as follows:

a. Defendants shall make an initial payment of Seven Thousand Five Hundred and no/100 Dollars (\$7,500.00) to plaintiffs on or before January 15, 1996; and

b. Defendants shall make a final payment to plaintiffs of Seven Thousand Five Hundred and no/100 Dollars (\$7,500.00) on or before June 15, 1996.
