

Articles of Merger

ARTICLES OF MERGER OF BARFIELD, MURPHY & SHANK, A GENERAL PARTNERSHIP WITH AND INTO RIVERCHASE OFFICE ROAD, L.L.C.

The undersigned domestic business entities do hereby execute the following Articles of Merger pursuant to Sections 10-12-55 et seq. of the Alabama Limited Liability Company Act (the "Act") of the Code of Alabama for the purpose of merging BARFIELD, MURPHY & SHANK, A GENERAL PARTNERSHIP, with and into RIVERCHASE OFFICE ROAD, L.L.C., an Alabama limited liability company.
