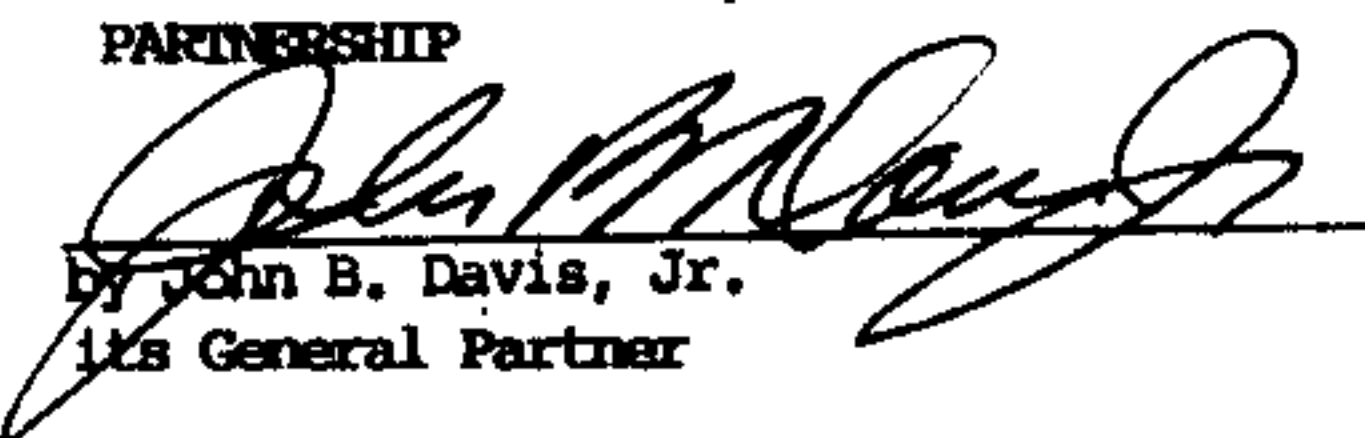
TO HAVE AND TO HOLD, to the said William A. and Sherry S. Millard, jointly with the right of Survivorship.
