That in consideration of ONE HUNDRED SEVENTY THOUSAND ONE HUNDRED & NO/100---- (\$170,100.00) DOLLARS to the undersigned grantor, Wynlake Construction, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Jeffrey D. Gleason and wife, Melissa Elaine Gleason (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama:

\$161,595.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

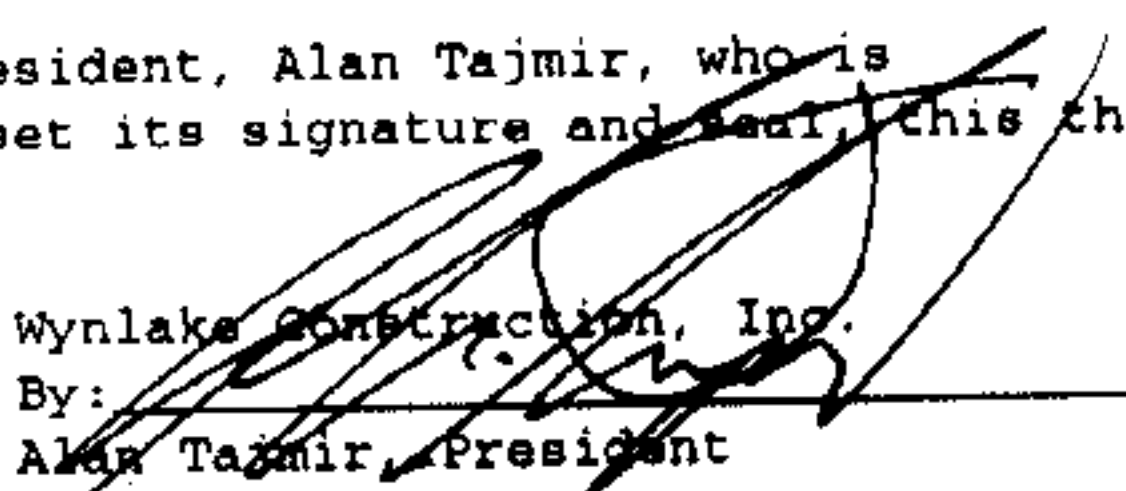

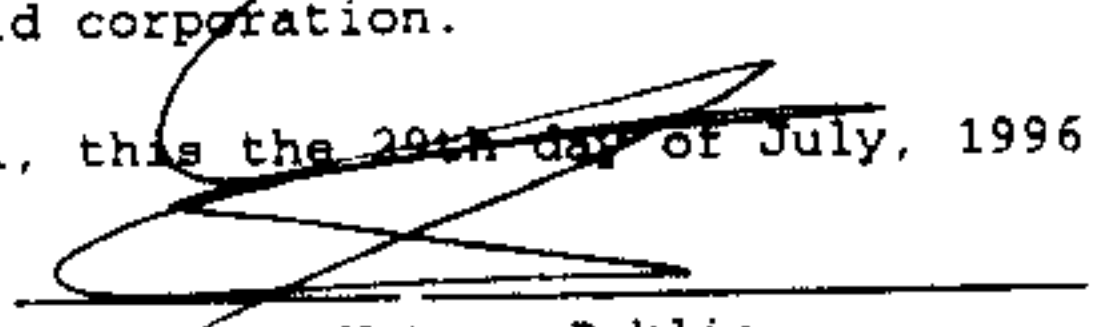
