Whereas, on December 11, 1981, Guaranty Federal Savings and Loan Association, Anniston, Alabama, merged with City Federal Savings and Loan Association under the name and charter of City Federal Savings and Loan Association; and

Whereas, on March 11, 1982, American Federal Savings and Loan Association, Alexander City, Alabama, merged with City Federal Savings and Loan Association under the name and charter of City Federal Savings and Loan Association; and

Whereas, on March 29, 1989, the Federal Home Loan Bank Board ("FHLBB") found the City Federal Savings and Loan Association, Birmingham, Alabama, to be insolvent and by FHLBB Resolutions No. 89-1045-P appointed the Federal Savings and Loan Insurance Corporation ("FSLIC") as Conservator for City Federal Savings and Loan Association; and
