

DELEGATION OF POWERS BY PARENTS

KNOW ALL MEN BY THESE PRESENTS, that in accordance with Section 26-2A-7, CODE OF ALABAMA, 1988, we, Tura Troth Holcomb and Boyce Lee Troth, of the City of Shelby County, Alabama, the natural parents of Autumn LYNN Troth age 18, born on the 3 day of JANUARY, 78, do hereby constitute and appoint Boyce Lee Troth of Shelby County, Alabama Autumn LYNN Troth GUARDIAN of our child, Autumn LYNN Troth. The GUARDIAN shall have the custody and power to consent to the following:

It is our intentions that the GUARDIAN shall have all the powers of the heretofore stated except the power to consent to marriage or adoption of our child, for a period not exceeding one year from the date hereof. We further understand that this temporary "delegation" of our parental powers does not relieve us of the primary responsibility of our child.

GIVING AND GRANTING unto said GUARDIAN full power and authority to do, take and perform all and every act and thing whatsoever requisite, proper or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes for the benefit of our child, Autumn LYNN Troth, as we might or could do if personally present, hereby ratifying and confirming all that the said GUARDIAN shall lawfully do or cause to be done by virtue of this delegation of powers and the rights and powers herein granted.

The above delegation of powers of the GUARDIAN herein granted shall commence and be in full force and effect on the date set forth below; and such powers shall remain in full force and effect until ONE YEAR from the date set forth below.
