I, EMMA LITTLE WEBB, of the city of Tampa, Hillsborough County, Florida, do hereby make, publish and declare this my Last Will and Testament in manner and form following:

First: I direct that all my just debts and funeral expenses be paid as soon after my decease as conveniently can be done.

Second: I own an undivided one-fifth interest in the estate of C. E. Little of Auburn, Alabama. My brother, C. Felton Little, is executor of said estate, and I desire and order and direct that said estate shall continue to be held and administered as now being done so long as said estate is operated as a successful and profitable business and so long as a majority of the five interests in said estate desire the same to be continued.

Third: I give and bequeath the net income from my entire estate, including my interest in said estate of C. E. Little, to my husband, R. D. Webb, for the period of his natural life.

Fourth: Upon the death of my husband, R. D. Webb, I give, devise and bequeath all my estate of every nature and kind whatsoever and wheresoever situate to my three children, Charles Hubert Webb, of Atlanta, Georgia; Eleanor Webb Hayt, of Tampa, Florida; and David Lawrence Webb, of Tampa, Florida, equally, share and share alike, subject to the above provision for the continuance of the estate of the said C. E. Little, as provided in item "Second" hereof.

Fifth: I hereby nominate, constitute and appoint my husband, R. D. Webb, as executor and trustee of my estate, and I direct that he shall not be required to give any bond or security for the proper discharge of his duties.

Sixth: In the event of the death, resignation, refusal or inability of the said R. D. Webb to act as executor and
