Know all men by these presents, that in consideration of love and affection and to verify a boundary line, to the undersigned grantor in hand paid by the grantee herein, the receipt whereof is acknowledged, we, Tressie Audrice Hughes Jones, of 201 Jones Road, Montevallo, AL 35115; Donald Delane Jones, Sr., of 225 Jones Road, Montevallo, AL 35115; Aligean Jones Holloman, of Indiana; and Shirley Jones McMillan, of Gainsborough, TN; being all the heirs at law of J C Jones, deceased (his widow and all his children), do grant, bargain, sell, and convey unto Marie W Jones of 145 Jones Road, Montevallo, AL 35115 (herein referred to as grantee, whether one or more) the following described real estate situated in Shelby County, Alabama, to-wit:
