That in consideration of TWO HUNDRED THIRTY SEVEN THOUSAND NINE HUNDRED & NO/100---- (\$237,900.00) DOLLARS to the undersigned grantor, Faith Homebuilders, Inc. a corporation, (herein referred to as the GRANTOR), in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto William M.
