Begin at the Southwest corner of the SW 1/4 of the SE 1/4, Section 32, Township 21 South, Range 1 West, being a point in place and in accordance with a survey of Horace Ray Edwards, RLS #9132, dated 1-30-7; thence Northerly along the West boundary of said 1/4-1/4 for 152.16 feet to an iron; thence turn an angle of 102 degrees 46 minutes 10 seconds to the right and run 250.01 feet to an iron; thence turn an angle of 65 degrees 00 minutes 52 seconds to the left and run 60.00 feet to an iron, being a point on the Southwest margin of County Road #97; thence turn an angle of 82 degrees 59 minutes 33 seconds to the right and run along said margin of County Road 97, being along a curve to the right, having a radius of 320.51 feet and central angle of 48 degrees 34 minutes 36 seconds, for an arc distance of 271.74 feet to an iron, being a point on the North right of way line of Alabama Highway #25; thence turn an angle of 89 degrees 36 minutes 51 seconds to the right from the tangent to the curve, and run Westerly along said Alabama #25 right of way for 235.21 feet to a concrete right of way monument; thence continue along said right-of-way along a curve to the left, having a radius of 1602.61 feet and a central angle of 4 degrees 06 minutes 44 seconds, for an arc distance of 115.02 feet to a point; thence turn an angle of 81 degrees 07 minutes 16 seconds to the right and run 156.57 feet to a point; thence turn an angle of 65 degrees 56 minutes 59 seconds to the left and run 25.00 feet to the point of beginning. Said parcel is lying in the SW 1/4 of SE 1/4 Section 32, Township 21 South, Range 1 West and the NW 1/4 of NE 1/4 of Section 5, Township 22 South, Range 1 West.
