INSTRUCTIONS:

Only one copy of such additional sheets need be presented to the filing officer with a set of three copies of form UCC-3. - If collateral is crops or goods which are or are to become fixtures, describe generally the real estate and give name of record owner.
   At the time of filing, filing officer will return third copy as an acknowledgement.
