You and I have discussed two leases that you have with C. E. Little Estate in Shelby County, Alabama. One is for a lease on hay land of approximately 100 acres which you are leasing for \$1,000.00 a year. You have had one cutting for the year 1996, and expect to do a second cutting by the middle of August, 1996. You and I have agreed that you will have, therefore, used up approximately 2/3 of your lease but will be unable to make the third cutting unless other arrangements are made with the new owner. I have proposed, and you agreed, to accept the sum of \$333.00 as full satisfaction for the termination of the lease for the year 1996.

Next, you and I entered into an agreement on February 27, 1995 in which you were to clear approximately 100 additional acres, which had been idle, and use that land for hay. This agreement was to be for a period of five years, originally estimated at \$5,000.00. It is my understanding that additional expenses were incurred and that the total amount you spent thus far is \$6,500.00. By the middle of August, 1996, you will have occupied the property approximately 19 out of the 60 months, leaving a remainder of 41 months on the lease of five years.

You and I have agreed that C. E. Little Estate owes you the sum of \$4,441.53. It is our intention to forward a check totaling \$4,774.53 for both these leases.
