

ORDINANCE NO.96-11

WHEREAS, on the 28th day of August, 1996, Concord Baptist Church filed a petition with the City Clerk of the City of Calera, Alabama, as required by 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the City of Calera, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limit of the City of Calera, Alabama, and the signatures;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CALERA, AS FOLLOWS:

Commence at the Northwest corner of the NE1/4 of Section 4, Township 22 South, Range 2 West; thence Easterly along the North section line to the northerly Right-of-Way of County Road 22 and point of beginning; thence Northeasterly along the Right-of-Way 1066.26 feet; thence left 150 deg. 21 feet 59 inches, 308.88 feet; thence left 16 deg. 15 ft 00 inches, 478.00 feet; thence right 20 deg. 24 ft. 20 inches to the Eastern Right-of-Way line of the CSX Railroad; thence Southerly along the Right-of-Way to the North Right-of-Way of County Road 22; thence Northeasterly along the Right-of-Way to the point of beginning.

1. That the City of Calera, Alabama, does adopt this Ordinance assenting to the annexation of the following described property to the municipality of the City of Calera:

2. That the corporate limits of the City of Calera, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.



4. That the Zoning Map of the City of Calera, Alabama, and any other official maps or surveys of the City shall be amended to reflect the annexation of the above described property, and that a copy of this Ordinance be transmitted to the City Planning commission and the Zoning Administrator.

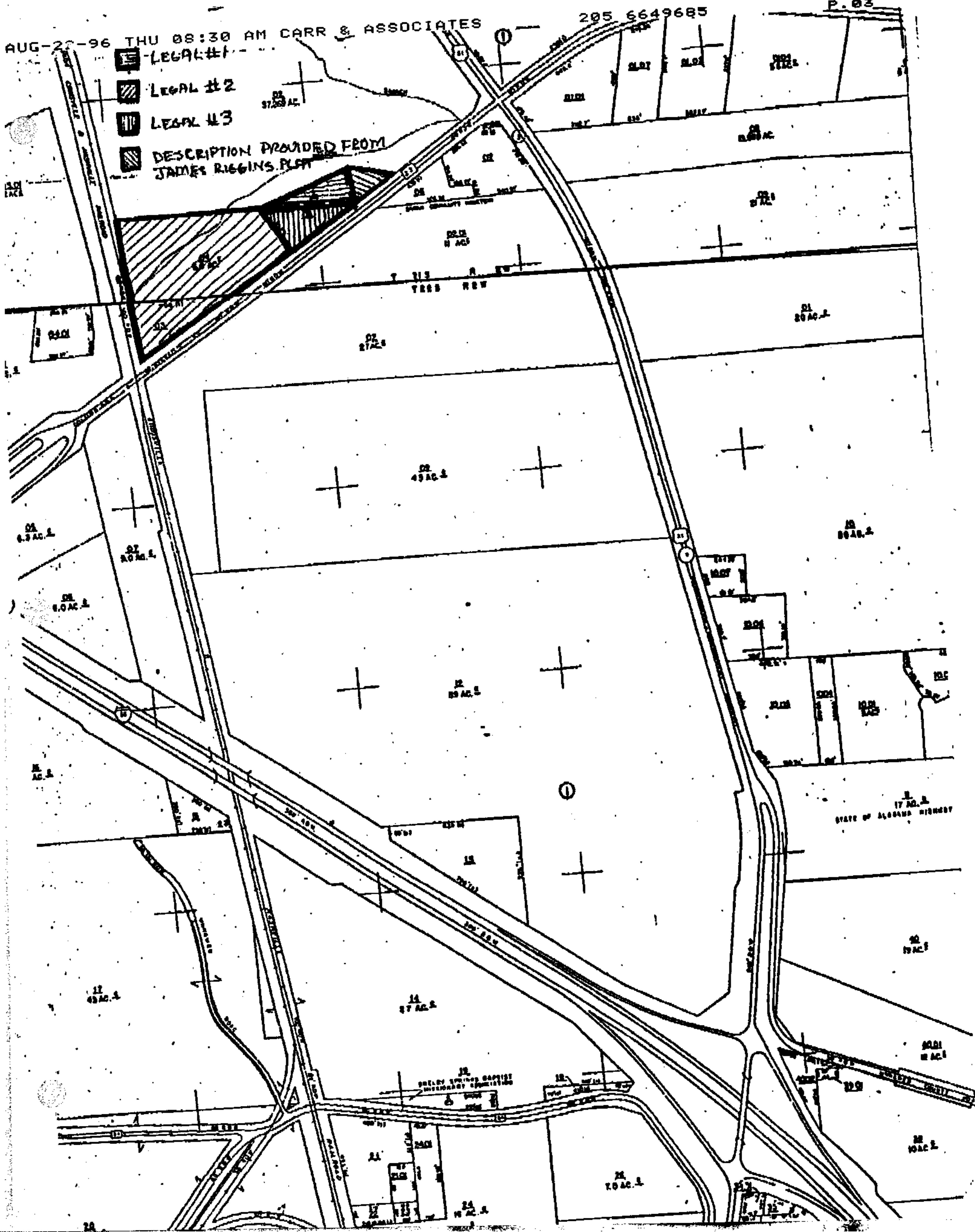
